**RE: Proposed Mountain View County and M.D. of Bighorn Intermunicipal Development Plan**

You are receiving this notification letter as you are identified as the owner of land that falls within the Intermunicipal Development Plan (IDP) Area. (See the attached map). Both municipalities will hold separate Public Hearings to receive input from landowners within their municipal boundary. The M.D. of Bighorn scheduled a Public Hearing on Tuesday May 28, 2019 at 10:00 a.m.

**Mountain View County scheduled a Public Hearing on Wednesday May 22, 2019 at or after 9:00 a.m. to consider the IDP between Mountain View County and the M.D. of Bighorn.** A copy of Bylaw No. 02/19 and Schedule "A" is available on our website for your review.

The Public Hearing will be held at the County Office in Council Chambers at 1408 Township Road 320, Didsbury, Alberta. Any person or persons presenting their views to the Council of Mountain View County at the Public Hearing to be held in connection with the proposed Intermunicipal Development Plan shall state their name, location of residence and whether they are speaking on their own behalf or for a group. Presentations are limited to five (5) minutes; a request for additional time may be made. Only one (1) presentation per person or group is allowed, with the exception of the applicant.

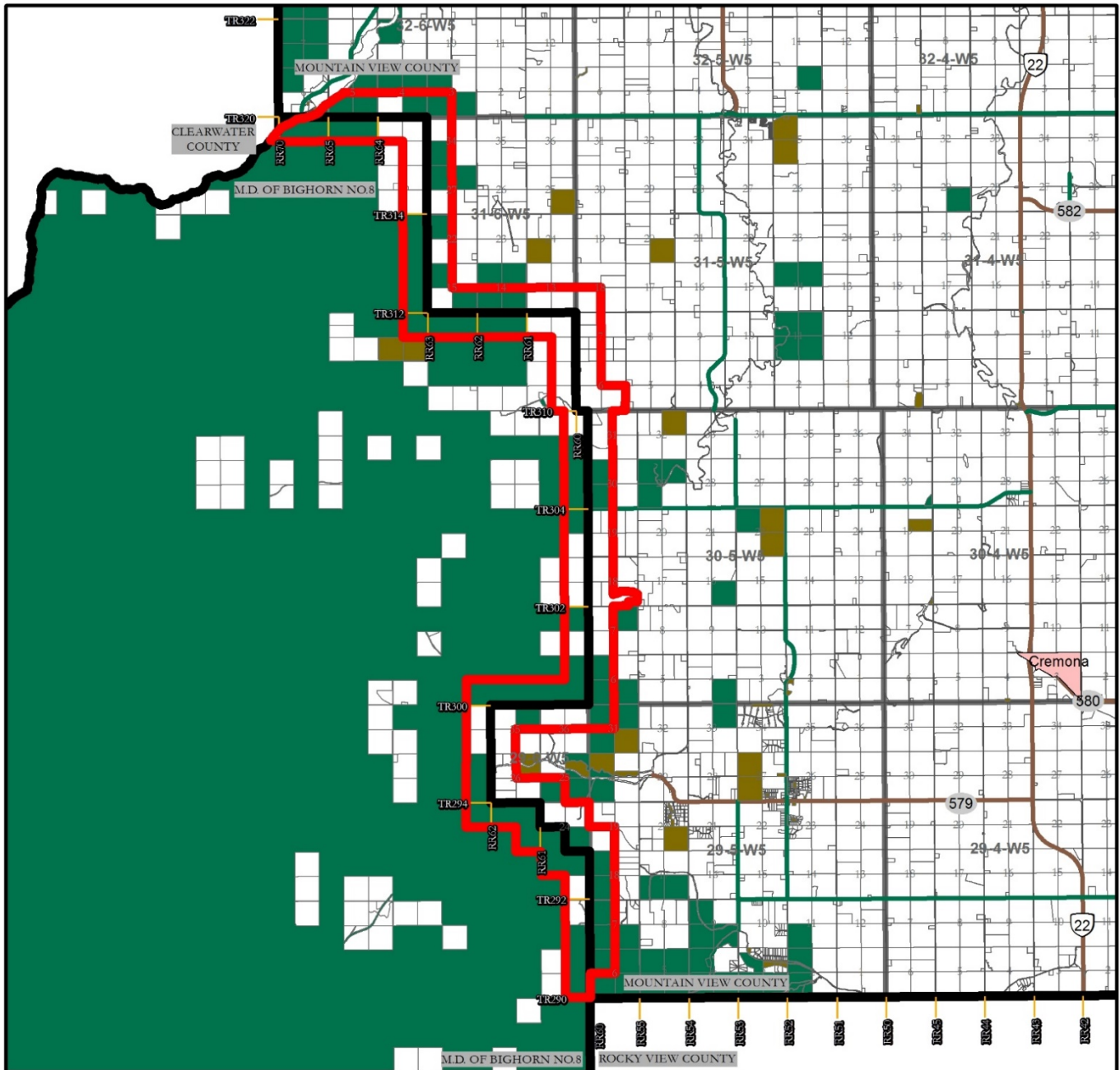
Please note that the Agenda for the Council meeting will be available for viewing two (2) days prior to the Public Hearing on our website at <http://www.mountainviewcounty.com/council-boards-services/council-meetings> Written submissions received after the comment deadline of 9:00 a.m. (two (2) days prior to the Public Hearing) will be copied and presented to Council at the Public Hearing. Council will, at their discretion, consider and pass a motion if they accept the information received after the comment deadline. Any person who wishes to address Council may do so at the Public Hearing.

The feedback from the Public Hearings will be shared between Councils including consideration of any amendments prior to final approval of the Bylaws at future Council meetings; potentially during the June 12<sup>th</sup> Council meeting at Mountain View County. Once the IDP is approved, the IDP will guide future planning and development of lands within the IDP Area.

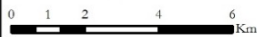


**Ownership Map**
